Section 3. Composition and Information on Ingredients

This product contains the following components and mixture of the following substances with non-hazardous additions.

ULB Buffer

Contains 30-60% Guanidine Thiocyanate (CAS #: 593-84-0), 10 -20% Triton X-100 (CAS #: 9002-93-1

UW Buffer

Contains 30-60% Guanidine Thiocyanate (CAS #: 593-84-0), 10 -20% Triton X-100 (CAS #: 9002-93-1)

UM Bead Solution

Contains 4.0% Silica Coated Magnetic nanoparticles, .02% Sodium Azide (CAS #: 26628-22-8)

UE Buffer

This buffer contains no substances which at their given concentration, are considered to be hazardous

UFC Buffer

Contains 15-50% Guanidine Hydrochloride (CAS #: 50-01-1) and 5 -15% Triton X-100 (CAS #: 9002-93-1)

BFC Buffer

Contains 30-50% Guanidine Thiocyanate (CAS #: 593-84-0) and 0.1-1% N-lauroylsarcosine (CAS #: 137-16-6)

Proteinase K

Contains 1-5% Proteinase K (CAS #: 39450-01-6)

Magnetic Bead Solution

Contains 4.0% Silica Coated Magnetic nanoparticles, and 0.02% Sodium Azide (CAS #: 26628-22-8)

FCW1 Buffer

Contains 30-60% Guanidine Hydrochloride (CAS #: 50-01-1) and 10 -20% Triton X-100 (CAS #: 9002-93-1)

FCW2 Buffer

This buffer contains no substances which, at their given concentration, are considered to be hazardous

FCE Buffer

This buffer contains no substances which, at their given concentration, are considered to be hazardous

Section 4. First Aid Measures

Eye: Eye irritation. Flush immediately with large amounts of water for at least 15 minutes. Eyelids should be held away from the eyeball to ensure thorough rinsing. Get immediate medical attention.

Skin: Itching or burning of the skin. Immediately flush the skin with plenty of water while removing contaminated clothing and shoes. Get immediate medical attention. Wash contaminated clothing before reuse.

Inhalation: Remove exposed person from source of exposure to fresh air. If not breathing, clear airway and start cardiopulmonary resuscitation (CPR). Avoid mouth-to-mouth resuscitation.

Ingestion: Get immediate medical attention. Do not induce vomiting unless directed by medical personnel.

Section 5. Fire Fighting Measures

Extinguishing media: water spray, carbon dioxide, dry chemical powder or appropriate foam.

Special firefighting procedures: wear self-contained breathing apparatus and protective clothing to prevent contact with skin and eyes.
