3. COMPOSITION/INFORMATION ON INGREDIENTS

This product contains the following components and mixture of the following substances with non-hazardous additions.

Reagent A: 50 mL Liquid

Non-hazardous. Reagent B: 6 mL Liquid

Contains 0.1-5% tris(2-pyridyl)-s-triazine (CAS #: 3682-35-7) Reagent C: 6 mL Liquid

Contains 0.1-5% ferric chloride (CAS #: 7705-08-0) Uric Acid Standard: 1 mL Liquid

Non-hazardous.

Blank Control: 1 mL Liquid Non-hazardous.

4. FIRST AID MEASURES

Eve: Eve irritation. Flush immediately with large amounts of water for at least 15 minutes. Eyelids should be held away from the eyeball to ensure thorough rinsing. Get immediate medical attention.

Skin: Itching or burning of the skin. Immediately flush the skin with plenty of water while removing contaminated clothing and shoes. Get immediate medical attention. Wash contaminated clothing before reuse.
