#### 3. COMPOSITION/INFORMATION ON INGREDIENTS

This product contains the following components and mixture of the following substances with non-hazardous additions.

#### Assay Buffer: 20 mL Liquid

Contains 0.1-1% sodium cholate (CAS #:206986-87-0), 0.1-1% Triton X-100 (CAS #: 9002-93-1) and 0.1-1% hydrazine (CAS #: 302-01-2) Enzyme Mix: 120 µL Liquid

Non-hazardous. PBS: 2 x 1.5 mL Liquid

Contains 0.1-2% potassium phosphate (CAS #: 16788-57-1) and 0.1-1% sodium chloride (CAS# 7647-14-5)

### Precipitation Reagent: 1.5 mL liquid

Contains 1-30% poly(ethylene glycol) (CAS #: 25322-68-3)

### Dye Reagent: 120 µL liquid

Contains 10-99% dimethyl sulfoxide (CAS#: 67-68-5).

Standard: 1 mL Liquid

Contains 0.3% cholesterol (CAS #: 57-88-5)

### 4. FIRST AID MEASURES

Eve: Eve irritation. Flush immediately with large amounts of water for at least 15 minutes. Eyelids should be held away from the eyeball to ensure thorough rinsing. Get immediate medical attention.

Skin: Itching or burning of the skin. Immediately flush the skin with plenty of water while removing contaminated clothing and shoes. Get immediate medical attention. Wash contaminated clothing before reuse.

Inhalation: Remove exposed person from source of exposure to fresh air. If not breathing, clear airway and start cardiopulmonary resuscitation (CPR). Avoid mouth-to-mouth resuscitation.

Ingestion: Get immediate medical attention. Do not induce vomiting unless directed by medical personnel.
